Organizational Meeting • December 7, 2015

The Board Organization meeting of the Wattsburg Area School District Board of Education was held on December 7, 2015, at the Wattsburg Area Elementary Center.

President Nancy McNally called the meeting to order at 7:01 p.m. The following members were in attendance: Mr. Eric Duda, Dr. Bill Hallock, Dr. Andy Pushchak, Mr. Marty Pushchak, Mrs. Brenda Sandberg, Mr. Aaron Snippert, Mrs. Amanda Thayer-Zacks, and Mrs. Nancy McNally. Also in attendance were Mr. Kenneth Berlin, Superintendent; Mrs. Leslie Hutchinson, Assistant to the Superintendent, Mrs. Vicki Bendig Business Administrator and Solicitor McClure. The following member was absent: Mr. Josh Paris.

Mrs. Postlewaite addressed the board on the proposed earlier board meeting times.

Dr. Pushchak nominated Mr. Marty Pushchak as temporary president, Mr. Duda motioned the nominations be closed, seconded by Dr. Pushchak. In a voice vote, all members voted "Yes" for Mr. Pushchak and he was elected the temporary president.
