In a recorded roll call vote, the following members present voted “Yes”: Mrs. Smith, Mr. Watkins, Mr. Rzepka, Mrs. Afton, Mr. Duda, Mr. S. Rose, Mr. E. Rose, and Mr. Walko. Motion was carried unanimously.

Student Discipline Hearing – **Motion:** To adopt a resolution regarding a Student Discipline Hearing.

SHS student is hereby expelled from the Wattsburg Area School District commencing immediately and effective until the commencement of the second semester of the 2009-2010 school year.

SHS student will be placed immediately into an appropriate alternative education program.

If SHS student successfully completes his alternative education program, he may be readmitted to Seneca High School for the second semester of the 2009-2010 school year subject to a period of probation for one (1) full year. The condition of this probation shall include the following:

- SHS student will be subject to random unannounced searches by members of the School District Administration and these searches may include his person, his locker, his personal possessions and any car he may drive to school.
- SHS student must comply with all Sections of the Student Handbook and all District Policies.
- It is mandatory that SHS student participate in the Student Assistance Program.
- SHS student is required to visit with the school psychologist on such schedule that the school psychologist deems appropriate.
- Any serious infraction by SHS student or violation of the terms and conditions of this adjudication shall result in immediate expulsion and/or removal to an alternative educational setting.
- The Board of Education does not require, but strongly recommends that SHS student receive drug treatment and counseling from outside sources in addition to those services available through the Wattsburg Area School District.

Motion for approval was made by Mr. Duda, seconded by Mr. Watkins. In a recorded roll call vote, the following members present voted “Yes”: Mrs. Afton, Mr. Duda, Mr. S. Rose, Mrs. Smith, Mr. Watkins, Mr. Rzepka, and Mr. E. Rose. Mr. Walko abstained. Motion was carried unanimously.

Transportation Requests – **Motion:** To approve Seneca High School Autistic Support students to travel to Claytopia, Pizza Hut, and WalMart, Erie, Friday, December 5, 2008, \$100.00 (Funds from I.U. #5.) and **Motion:** To approve Seneca High School Autistic Support students to travel to Eastway Bowling, Wendy’s, and WalMart, Erie, Friday, December 12, 2008, \$92.00 (Funds from I.U. #5).
