## WATTSBURG AREA SCHOOL DISTRICT BOARD OF EDUCATION Work Session

August 10, 2020

The meeting of the Board Work Session convened on August 10, 2020 at 7:00 PM via Zoom Virtual Meeting platform.

Dr. Pushchak announced that if guest or citizens wished to address the board, they should use the Question and Answer function and they would be recognized and given 5 minutes to speak.

Mr. Berlin updated the Board with information released this morning from the PA Department of Health and Education statistics. If we follow the matrix we are in the moderate range (indicating yellow phase). There was discussion about how the district should open due to the rising numbers over the last two weeks The Principals shared their views on opening in the Yellow Phase and that the more lead time that's given would be helpful ready. Many questions were answered by Mr. Berlin regarding which phase to begin in and a consensus for opening in the Yellow Phase with the dates of September 8 through November 9, 2020 was decided. A resolution for opening in the Yellow Phase will be placed on the August 17, 2020 agenda. Mr. Berlin also shared that at present 120 students have registered for Fuel Education Cyber through the district.
